Our goal is to provide a two-year stipend for our current education and training teacher to compensate for additional time and effort spent to promote teaching as a career to our students and provide them with hands on experiences and CTSO conferences that will spark an increased interest in the field of education. Field site teacher stipends will be equally divided over a two-year period to encourage site teacher participation in the program for hands on student experiences. These expenditures will be adjusted based on student to site teacher need ratio. CTSO conference travel expenses include membership fees, registration fees and allowable meals, CTSO conferences will provide enrichment opportunities for students to explore the career of teaching and learn leadership roles. Adjustments to the program and budget will be reviewed regularly as follow-up feedback from participants is received and opportunities for improvement are identified. The current allocated funds total approximately \$69,000 for our education and training program including CTSO allocations.
